# Statement of intent

Excalibur Primary School is committed to providing emergency first aid provision in order to deal with accidents and incidents affecting staff, pupils and visitors. The arrangements within this policy are based on the results of a suitable and sufficient risk assessment carried out by the school in regard to all staff, pupils and visitors.

The school will take every reasonable precaution to ensure the safety and wellbeing of all staff, pupils and visitors.

This policy aims to:

- Ensure that the school has adequate, safe and effective first aid provision for every pupil, member of staff and visitor to be well looked after in the event of any illness, accident or injury, no matter how major or minor.
- Ensure that staff and pupils are aware of the procedures in the event of any illness, accident or injury.
- Ensure that medicines are only administered at the school when express permission has been granted for this.
- Ensure that all medicines are appropriately stored.
- Promote effective infection control.

Nothing in this policy will affect the ability of any person to contact the emergency services in the event of a medical emergency. For the avoidance of doubt, staff should dial 999 in the event of a medical emergency before implementing the terms of this policy and make clear arrangements for liaison with ambulance services on the school site.

# First Aid Policy

## 1. Legal framework

- 1.1. This policy has due regard to legislation and statutory guidance, including, but not limited to, the following:
  - Health and Safety at Work etc. Act 1974
  - The Health and Safety (First Aid) Regulations 1981
  - The Road Vehicles (Construction and Use) Regulation 1986
  - The Management of Health and Safety at Work Regulations 1999
  - The Reporting of Injuries, Diseases and Dangerous Occurences Regulations (RIDDOR) 2013
  - DfE (2015) 'Supporting pupils at school with medical conditions'
  - DfE (2019) 'Automated external defibrillators (AEDs)'
  - DfE (2021) 'Statutory framework for the early years foundation stage'
  - DfE (2022) 'First aid in schools, early years and further education'
- **1.2.** The policy is implemented in conjunction with the following trust and school policies:
  - Health and Safety Policy
  - Administration of Medicines Policy
  - Supporting Pupils with Medical Conditions Policy
  - Behaviour Policy
  - Child Protection and Safeguarding Policy
  - Lone Worker Policy
  - Learning Outside the Classroom and Educational Visits Policy

#### 2. Roles and responsibilities

- 2.1. This policy has due regard to legislation and statutory guidance, including, but not limited to, the following:
  - The overarching development and implementation of this policy and all corresponding procedures.
  - Ensuring that the relevant risk assessments, and assessments of the first aid needs of the school specifically, have been conducted.
  - Ensuring that there is a sufficient number of appointed first aiders within the school based upon these assessments.
  - Ensuring that there are procedures and arrangements in place for first aid during off-site or out-of-hours activities, e.g. educational visits or parents' evenings.
  - Ensuring that insurance arrangements provide full cover for any potential claims arising from actions of staff acting within the scope of their employment.

- Ensuring that appropriate and sufficient first aid training is provided for staff, and ensuring that processes are in place to validate that staff who have undertaken training have sufficient understanding, confidence and expertise in carrying out first aid duties.
- Ensuring that adequate equipment and facilities are provided for the school site.
- Ensuring that first aid provision for staff does not fall below the required standard and that provision for pupils and others complies with the relevant legislation and guidance.
- Ensuring that an 'appointed person' is selected from amongst staff to take the lead in first aid arrangements and procedures for the school.
- 2.2. The headteacher is responsible for:
  - The development and implementation of this policy and its related procedures.
  - Ensuring that all staff and parents are made aware of the school's policy and arrangements regarding first aid.
  - Ensuring that all staff are aware of the locations of first aid equipment and how it can be accessed, particularly in the case of an emergency.
  - Ensuring that all pupils and staff are aware of the identities of the school first aiders and how to contact them if necessary.
- 2.3. Staff are responsible for:
  - Ensuring that they have sufficient awareness of this policy and the outlined procedures, including making sure that they know who to contact in the event of any illness, accident or injury.
  - Securing the welfare of the pupils at school.
  - Making pupils aware of the procedures to follow in the event of illness, accident or injury.
- 2.4. First aid staff are responsible for:
  - Completing and renewing training as dictated by the governing board.
  - Ensuring that they are comfortable and confident in administering first aid.
  - Ensuring that they are fully aware of the content of this policy and any procedures for administering first aid, including emergency procedures.
  - Keeping up to date with government guidance relating to first aid in schools.
- 2.5. The appointed person is responsible for:
  - Overseeing the school's first-aid arrangements.
  - Taking charge when someone is injured or becomes ill.
  - Looking after the first-aid equipment, e.g. restocking the first aid container.
  - Ensuring that an ambulance or other professional medical help is summoned when appropriate.
  - Calling the emergency services where necessary.
  - Maintaining injury and illness records as required.

- Partaking in an appointed persons course, emergency first aid training, first aid at work, and refresher training where appropriate, to ensure they have knowledge of:
  - What to do in an emergency.
  - How to assess and monitor a casualty.
  - First aid for the unconscious casualty.
  - First aid for someone who is having a seizure.
  - Maintaining injury and illness records as required.
- Paediatric first aid

#### 3. First Aid Provision

- **3.1.** All staff will read and be aware of this policy, know who to contact in the event of any illness, accident or injury, and ensure that this policy is followed.
- 3.2. Staff will always use their best endeavours to secure the welfare of pupils.
- **3.3.** Anyone on the school premises is expected to take reasonable care for their own and other's safety.
- 3.4. The aims of this policy are to:
  - Ensure that the school has adequate, safe and effective first aid provision for every pupil, member of staff and visitor to be well looked after in the event of any illness, accident or injury, no matter how major or minor.
  - Ensure that staff and pupils are aware of the procedures in the event of any illness, accident or injury.
  - Ensure that medicines are only administered at the school when express permission has been granted for this.
  - Ensure that all medicines are appropriately stored.
  - Promote effective infection control.
- 3.5. Nothing in this policy will affect the ability of any person to contact the emergency services in the event of a medical emergency. For the avoidance of doubt, staff should dial 999 in the event of a medical emergency before implementing the terms of this policy and make clear arrangements for liaison with ambulance services on the school site.
- 3.6. To achieve the aims of this policy, the school will have suitably stocked first aid boxes in line with the assessment of needs. Where there is no special risk identified, a minimum provision of first aid items will be as follows:
  - A leaflet giving general advice on first aid
  - 20 individually wrapped sterile adhesive dressings, of assorted sizes
  - 2 sterile eye pads
  - 4 individually wrapped triangular bandages, preferably sterile

- 6 safety pins
- 6 medium-sized (approximately 12cm x 12cm) individually wrapped sterile unmedicated wound dressings
- 2 large-sized (approximately 18cm x 18cm) individually wrapped sterile unmedicated wound dressings
- 1 pair of disposable gloves
- Equivalent or additional items are acceptable
- All first aid containers will be identified by a white cross on a green background
- 3.7. The first aiders are responsible for examining the contents of first aid boxes, including any mobile first aid boxes for offsite use these will be frequently checked and restocked as soon as possible after use. Items will be safely discarded after the expiry date has passed.
- **3.8**. First aid boxes are in the following areas:
  - The school office
  - Key Stage 1 Corridor
  - Key Stage 2 Corridor
  - Mobile Classroom

## 4. First aiders

- 4.1. The main duties of first aiders will be to administer immediate first aid to pupils, staff or visitors, and to ensure that an ambulance or other professional medical help is called, when necessary.
- 4.2. First aiders will ensure that their first aid certificates are kept up-to-date through liaison with the School Business Manager.
- 4.3. First aiders will be responsible for ensuring all first aid kits are properly stocked and maintained. The first aid appointed person in the school office will be responsible for maintaining supplies.
- 4.4. The current first aid appointed persons will be listed at each first aid station and in the school office.

#### 5. Emergency procedures

- 5.1. If an accident, illness or injury occurs, the member of staff in charge will assess the situation and decide on the appropriate course of action, which may involve calling for an ambulance immediately or calling for a first aider.
- 5.2. If called, a first aider will assess the situation and take charge of first aider administration.

- 5.3. If the first aider does not consider that they can adequately deal with the presenting condition by the administration of first aid, then they will arrange for the injured person to access appropriate medical treatment without delay.
- 5.4. Where an initial assessment by the first aider indicates a moderate to serious injury has been sustained, one or more of the following actions will be taken:
  - Administer emergency help and first aid to all injured persons. The purpose of this is to keep the victim(s) alive and, if possible, comfortable, before professional medical help can be called. In some situations, immediate action can prevent the accident from becoming increasingly serious, or from involving more victims.
  - Call an ambulance or a doctor, if this is appropriate after receiving a parent's clear instruction, take the victim(s) to a doctor or to a hospital. Moving the victim(s) to medical help is only advisable if the person doing the moving has sufficient knowledge and skill to move the victim(s) without making the injury worse.
  - Ensure that no further injury can result from the accident, either by making the scene of the accident safe, or (if they are fit to be moved) by removing injured persons from the scene.
  - See to any pupils who may have witnessed the accident or its aftermath and who may be worried, or traumatised, despite not being directly involved. They will need to be escorted from the scene of the accident and comforted. Younger or more vulnerable pupils may need parental support to be called immediately.
- 5.5. Once the above action has been taken, the incident will be reported promptly to:
  - The headteacher.
  - The victim(s)'s parents.

#### 6. Reporting to parents

- 6.1. In the event of incident or injury to a pupil, at least one of the pupil's parents will be informed as soon as practicable.
- 6.2. Parents will be informed in writing of any injury to the head, whether minor or major, and be given guidance on the action to take if symptoms develop.
- 6.3. In the event of a serious injury or an incident requiring emergency medical treatment, the school office or pupil's teacher will telephone the pupil's parents as soon as possible.
- 6.4. A list of emergency contacts will be kept at the school office.

# 7. Offsite visits and events

7.1. Before undertaking any offsite visits or events, the teacher organising the trip or event will assess the level of first aid provision required by undertaking a suitable and sufficient risk assessment of the visit or event and the persons involved.

#### 8. Storage of medication

- 8.1. Medicines will always be stored securely and appropriately in accordance with individual product instructions.
- 8.2. All medicines will be stored in the original contained in which they were dispensed, together with the prescriber's instructions for administration, and properly labelled, showing the name of the patient, the date of prescription and the date of expiry of the medicine.
- 8.3. All medicines will be returned to the parent for safe disposal when they are no longer required or have expired.
- 8.4. An emergency supply of medication will be available for pupils with medical conditions that require regular medication or potentially lifesaving equipment, e.g. an EpiPen.
- 8.5. Parents will advice the school when a child has a chronic medical condition or severe allergy so that an Individual Healthcare Plan can be implemented and staff can be trained to deal with any emergency in an appropriate way. Examples of this include epilepsy, diabetes and anaphylaxis. A disclaimer will be signed by the parents in this regard.

#### 9. Illnesses

- 9.1. When a pupil becomes ill during the school day, the parents will be contacted and asked to pick their child up as soon as possible.
- 9.2. A quiet area will be set aside for withdrawal and for pupils to rest while they wait for their parents to pick them up. Pupils will be monitored during this time.

#### 10. Allergens

10.1. Where a pupil has an allergy, this will be addressed via the school's Allergen and Anaphylaxis Policy.

#### 11. Consent

- 11.1. Parents will be asked to complete and sign a medical consent form when their child is admitted to the school, which includes emergency numbers, details of allergies and chronic conditions, and consent for the administration of emergency first aid these forms will be updated periodically.
- 11.2. Staff do not act 'in loco parentis' in making medical decisions as this has no basis in law staff will always aim to act and respond to accidents and illnesses based on what is reasonable under the circumstances and will always act in good faith while having the best interests of the pupil in mind guidelines will be issued to staff in this regard.

#### 12. Monitoring and review

- 12.1. This policy is reviewed every three years by the governing board, and any changes communicated to all members of staff.
- 12.2. Staff will be required to familiarise themselves with this policy as part of their induction programme. Staff will be informed of the arrangements that have been made in connection with the provision of first aid, including the location of equipment, facilities and personnel.
